

2014 Organizational Meeting

January 2, 2014

Before the 2014 Organizational meeting was held Town Justice Sandy Cameron administered the Oath of Office to incoming Supervisor Dan Acton, Town Board member Bob Ormsby, Highway Superintendent Jamie Mansfield, and Town Justice Wende Bush.

The 2014 Organizational meeting was then called to order by Supervisor Dan Acton at 5:10 pm. Board members present were Dan Acton, Fion MacCrea, Bob Ormsby, Jerry Snyder. Absent was Mary Stearns. Also present was Town Justice Sandy Cameron, and Town Clerk Janice Burdick.

Supervisor Acton appointed Fion MacCrea Deputy Supervisor. Mr. Acton thanked Jerry Snyder for his service serving as Deputy under the former Supervisor. Judge Cameron administered the Oath of Office to Fion MacCrea.

A motion was made by Jerry Snyder, seconded by Fion MacCrea and carried 4-0 appointing Janice Burdick to a 2 year term as Town Clerk, Tax Collector/ Registrar of Vital Statistics. Judge Cameron then administered the Oath of Office to Mrs. Burdick. As Chief Fiscal Officer, The Supervisor and the Deputy Supervisor are authorized to sign checks, etc. on all Town accounts except the Town Clerk and Tax Collector Accounts.

Board of Assessment Review – John Buckwalter – 5-year term. 3 year term to fill Dan Acton's unexpired term.
